I. Executive Summary

The 2025 Community Health Needs Assessment (CHNA) for **Cloud County, Kansas**, was completed on behalf of **North Central Kansas Medical Center (NCKMC)** in partnership with the **Cloud County Health Department** and other local stakeholders. This CHNA fulfills IRS 501(r)(3) requirements for nonprofit hospitals to conduct a community health needs assessment every three years.

Purpose: This report identifies and prioritizes unmet health needs, highlights community strengths, and provides a roadmap for health improvement strategies. It is designed to foster collaboration among health providers, community organizations, and residents to create a healthier Cloud County.

Key Prioritized Health Needs

Following stakeholder surveys and secondary data review meeting, the following unmet needs were prioritized:

1. **Mental Health Services & Provider Access** – Shortage of providers; high number of poor mental health days reported.
2. **Healthcare Workforce & Staffing**- Increasing access.
3. **Substance Use Prevention & Treatment** – Concerns about alcohol, tobacco, vaping, and drug use.
4. **Chronic Disease & Obesity** – Elevated rates of diabetes, hypertension, and obesity. According to County Health Rankings and Roadmaps, Cloud County, Kansas has a premature death rate 17% higher than the overall rate for Kansas and 19% higher than the national rate. The leading cause of death in persons under the age of 75 is diseases of the heart, at a rate of 188.3 per 100,000.

Additionally, only 9.3% of adults in Cloud County are doing enough physical activity to meet both the aerobic and strengthening exercise recommendations, and the percentage of adult who are overweight is 36.3%. According to county health rankings and roadmaps, 80% of the population of Cloud County, Kansas has sufficient access to locations for physical activity.

Community Strengths

- High educational attainment (96% high school completion).
- Good access to specialty doctors, outpatient services, and surgical procedures.
- Low rates of low birth weight infants.

- Low Unemployment

II. Methodology

a) CHNA Scope and Purpose

The **Affordable Care Act (ACA)** requires nonprofit hospitals to conduct a CHNA every three years. This includes: - Identifying community health needs. - Prioritizing unmet needs. - Gathering input from a broad range of stakeholders. - Making findings publicly available.

b) Local Collaborating CHNA Parties

North Central Kansas Medical Center (NCKMC) – Primary hospital provider for Cloud County.

Cloud County Health Department – Public health and prevention services.

Annual Evaluation of Critical Access and Rural Health Clinic Services Cloud County Health Center d/b/a North Central Kansas Medical Center

Cloud County Health Center, doing business as North Central Kansas Medical Center, conducts an annual evaluation of its Critical Access Hospital and Rural Health Clinic services and overall performance. This comprehensive review incorporates valuable input from both community members and our dedicated medical providers.

The most recent evaluation was completed on **April 9, 2025**.

During this review, the Medical Staff highlighted several key updates and future plans:

- **Expansion of Mental Health Services**
The Medical Center is preparing to welcome a **Mental Health Nurse Practitioner** in **late 2025**. By offering earlier intervention and improved access to mental health care


within the clinic, we aim to reduce the number of patients experiencing mental health crises requiring emergency room services.

- **Growth in Patient Volume at Clyde Clinic**

With the implementation of **expanded clinic days** at the **Clyde Clinic**, patient visits have increased significantly — from an average of **14 patients per month** to **45 patients per month**. This growth demonstrates the positive impact of improved access and scheduling on community healthcare utilization.

North Central Kansas Medical Center remains committed to enhancing patient care, expanding essential services, and strengthening partnerships within the community to meet the evolving healthcare needs of the region.



- **Preventable Hospital Stays (Medicare):** 6,412/100k – higher than U.S. norm.
- **Childcare Cost Burden:** 18% of median household income (better than U.S. avg of 29%).

History: The North Central Kansas Medical Center was dedicated in October 2022. Construction of the facility began in early 2020 along College Drive in Concordia, Kansas. Formally known as Cloud County Health Center, North Central Kansas Medical Center is a critical access hospital and an affiliate of Salina Regional Health Center. Our rich history started with the Sisters of St. Joseph when they established the hospital in 1903. The following timeline outlines the history of our hospital in Cloud County:

- **1903-** The Sisters of St. Joseph established the hospital on 5th Street in Concordia. This is now the Manna House of Prayer.
- **1949-** Inadequacy of space forced the Sisters to start construction of a new building.
- **1951-** The new, completely modern, 150-bed hospital was dedicated on March 6, and was located at 1100 Highland Drive in Concordia.
- **1985-** Ownership of the hospital was transferred to the Sisters of St. Joseph in Wichita.
- **1995-** Ownership was transferred to Salina Regional Health Center.
- **2003-** The hospital became a stand-alone non-profit facility, Cloud County Health Center.
- **2016-** Cloud County Health Center formed an affiliation with Salina Regional Health Center with the goal of improving patient care in the region by better coordinating services between the two hospitals.
- **2019-** A working group of community members helped assess the need for a new facility. This group recommended a new hospital and encouraged a funding solution that was not tax-payer funded.
- **2021-** The community broke ground on the new North Central Kansas Medical Center. The 82,000 sq. ft. facility would provide all of the services of Cloud County Health Center with the addition of a permanent MRI, a zero-entry therapy pool, and a dedicated women's suite in radiology.
- **2022-** North Central Kansas Medical Center, a 14 bed facility, welcomed its first patients. The old hospital located on Highland Drive was demolished and the hospital donated the land to the City of Concordia to fulfill housing needs for the community.

Overview & Accessibility

The **Cloud County Health Department**, located at 910 W 11th St, Concordia, KS, 66901, operates by appointment and provides a broad spectrum of vital public health services to the community. Contact is made via phone at **(785) 243-8140** or email at **health@cloudcountyks.org**

Clinical Services & Preventive Programs

- **Sexually Transmitted Infections (STIs) & Testing:** Offers testing and treatment for a wide range of STIs including chlamydia, gonorrhea, syphilis, herpes, and hepatitis A, B, and C
- **HIV Services:** Provides conventional HIV testing, accompanied by pre- and post-test counseling, education, and partner notification services
- **Vaccinations:** Administers vaccines including HIV-related prevention measures, HPV (human papillomavirus), hepatitis A and B, and adult hepatitis B vaccinations
- **Family Planning:** Access to contraceptive counseling, reproductive health support, and related services
- **Cancer Screenings and Related Labs:** Screening services for preventive care (including reproductive cancer prevention) are part of their offerings
- **Basic Health Screenings & Education:** Historically, the department has provided:
 - Physical exams, pregnancy and STD testing, blood pressure/BMI checks, urinalysis, blood sugar and hemoglobin screenings
 - Injections such as B12 and Zostavax
 - General lab screenings (CBC, cholesterol, PSA)
 - Health counseling and contraception education

WIC (Women, Infants, and Children) Nutrition Program

- Offers services including:
 - Personalized nutrition counseling and education
 - Healthy food vouchers
 - Breastfeeding support and immunization screening/referral
 - Health and nutrition classes, guidance on meal planning, budget-friendly shopping, and caring for a new baby
- Aimed at income-eligible pregnant women, new mothers, infants, and children under age 5 (and fathers applying for their children)

Home Health Services

Through the **Cloud County Home Health Agency**, the department offers:

- **Medicare-certified** skilled nursing
- Physical, occupational, and speech therapy
- Home health aide services—designed to support patients with daily living and recovery needs in their own homes.

Support & Care Coordination

- **Case management** services are available to assist individuals—particularly those with HIV/STI or other ongoing health needs—in navigating health care, resources, and treatment

In summary, the Cloud County Health Department delivers comprehensive public health services—ranging from infectious disease prevention and family planning to nutrition support and in-home care. Their mission is centered on accessible, community-oriented health promotion.

V. Detail Exhibits

a) Patient Origin & Access to Care


Our analysis reviewed a full year of patient data, examining the number of unique individuals from each ZIP code who utilized the hospital and the Family Care Center between July 2024 and July 2025. Importantly, this data reflects the number of patients by ZIP code, not the total number of visits. The following sections summarize the geographic distribution of patients and highlight the ZIP codes with the highest utilization.

Hospital Visits:

- Total individuals: 20,418
- Unique ZIPs represented: 271
- Top ZIP: 66901 with 14,014 individuals
- Concentration:
 - Top 3 ZIPs account for 77.21% of volume
 - Top 5 ZIPs: 81.98%
 - Top 10 ZIPs: 90.01%

Pattern: The hospital draw is highly concentrated around 66901 and nearby 669xx/674xx ZIPs—indicative of a core service area in North Central Kansas with a steep drop-off outside that core. The long tail of 200+ additional ZIPs contributes ~10% collectively.

Top-15 ZIPs (Hospital): 66901, 66938, 66948, 66935, 67445, 66937, 67466, 67417, 66966, 67420, 67436, 67401, 66930, 66949, 66939.



- Total individuals: 16,938
- Unique ZIPs represented: 197
- Top ZIP: 66901 with 11,780 individuals
- Concentration:
 - Top 3 ZIPs account for 78.05%
 - Top 5 ZIPs: 82.72%
 - Top 10 ZIPs: 90.77%

Pattern: The FCC panel is similarly concentrated—nearly identical shape to the hospital—with slightly fewer total distinct ZIPs, suggesting an even tighter primary care catchment.

b) Public CHNA Notice / News




























Physician Demand Methodology

3Dhealth also makes telephone calls to test for:

Age	Physician ages or medical school graduation dates not populated while compiling the database are collected.
Locations	Physician FTEs are adjusted for physicians that spend time practicing at multiple office locations, both in and outside the CMS Service Area.
Specialties	If a physician practices multiple sub-specialties, his or her FTE is split between the sub-specialties.
Productivity	Physician FTEs are adjusted for time spent performing non-clinical duties, such as teaching, research, or administrative responsibilities.
