Cloud County Community Health Improvement Plan 2022-2025

Introduction

On April 28, 2022, the Community Health Needs Assessment Committee met and discussed ways to involve the community in addressing the most important health needs of Cloud County. The group decided to survey the community, asking for their input on priority of the following areas:

- Obesity
- Depression/Mental Health
- Diabetes
- Heart Disease
- Tobacco Use Including vaping and chewing
- Stroke
- Trauma/Falls
- Hypertension (high blood pressure)
- High cholesterol
- Substance Abuse
- Transportation to Medical Services

The survey was launched through all forms of media for a period of six weeks. Posters included a QR code for online access. Printed surveys were also made available in several public places.

118 surveys were received and tabulated. The Community Health Needs Assessment Committee met in July to review the results and discuss an implementation plan. The Committee consists of 25 members from various organizations in the community.

The Federal Patient Protection and Affordable Care Act (PPACA) requires that tax-exempt hospitals complete this assessment (CHNA) once every three years and then adopt a written strategy to be called here the Cloud County Community Health Improvement Plan (CHIP). County Health Departments are also required to use the CHIP in their program planning efforts.

Cloud County Health Center (CCHC) is required to formally adopt the CHIP within the current tax year that the CHIP was completed. It is then expected to monitor this plan and develop an annual report on its progress.

This Plan addresses priority need areas identified by the CHNA Committee. This plan covers the next three years until a new or revised CHIP is developed as required. It details specific tasks to be completed, how these tasks will be measured, who will be responsible for completing the identified tasks, and target dates for completion of each task.
